BACKGROUND

Galloway Ridge Inc., is a tax-exempt, not-for-profit corporation. In support of that status Galloway Ridge engages in community benefit activities and charitable projects by identifying and helping alleviate unmet needs of special populations in Chatham County, including children and youth, the elderly, the underprivileged and minorities. It also supports activities that foster housing care and services for older adults. The Galloway Ridge Charitable Fund, financed through philanthropic contributions, volunteer efforts or endowments, is among the vehicles used to support the mission.

FUNDING

Grants will be awarded for a term of one year. Grant funds may be requested for any administrative or program expenses and grants may be used to maintain existing successful programs that have demonstrated effectiveness. A total of \$85,000 in grant funds is available for distribution this year.

ELIGIBILITY

Grants will be awarded to 501(c) (3) organizations that serve Chatham County, to Chatham County Public Schools and to other Chatham County governmental units. Agencies are limited to one request each year in the grants process. Agencies that have received funding from Galloway Ridge in the past are eligible to apply.

APPLICATION PROCEDURES

Application is attached. Please adhere to the length limitation criteria and use this form ONLY. Applications must be submitted by 4:00 pm on October 12, 2018. The Distribution of Funds Committee of the Charitable Fund will serve as the selection committee. Applicants will be notified of decisions by the end of November, 2018.
